With reference to the approval given vide note-sheet dated 08.10.2015 we published NIT for Rate contract for Supply and Installation Tablet and Single Fingerprint Scanner Device and other items for Aadhaar Enrolment. In response to the above NIT, seven parties have submitted their competitive offers for the same by the due date.

The technical bids were opened on 19-10-2015, and the commercial bids were opened on 20.10.2015, in presence of the bidder's/representatives and committee members.

The comparative statements of the Commercial offers received for the said work, is enclosed as per Annexure-"A".

As directed parties were to demonstrate their products offered to ascertain functionality on UID software on 23 and 26th Oct. The details of functioning test report is placed at Annexure-'B'. Parties were also asked vide email to match the L-1 rates.

M/s Smart chip vide email dated 29.10.2015 informed that the rates for Item No. 5 (Iris capturing device) and Item No. 6 (Fingerprint capturing device) while quoting has got interchanged but agreed to accept combo rates as Iris capturing device and Fingerprint capturing device are supplied in a sets. Since this has resulted in change in quoted price for Item No. 5 & 6 by the vendors. Committee propose to reject this proposal for Item No 5 (Iris capturing device) & 6 (Fingerprint capturing device) however Item No. 2 (Single Fingerprint Scanner Device) for Enrolment of Children 0 - <5 Yrs shall be considered for further evaluation as parties were allowed to participant for any or all items as per tender.

Accordingly, Committee propose to offer L-1 rates received for acceptance by other vendors.
